

# Watch Wis. Officer Stop Knife-Wielding (Suspect) Threatening Polling Place

West Bend police were called in when a man brandishing a knife disrupted a polling place at the library by demanding poll workers "stop the voting".

WEST BEND, WI—A man pulled a knife and demanded poll workers "stop the voting" at a West Bend polling place Tuesday afternoon, the West Bend Police Department reported.

Reported at 12:35 p.m. Tuesday at West Bend Community Memorial Library, the incident ended with the suspect being taken in to custody, no injuries, and voting being able to resume at the library in less than an hour, according to the WBPD.

"The Police Department would like to thank the library staff for taking quick action and voters who waited patiently to vote," the WBPD said in a Facebook post. "The incident remains under investigation and charges will be forthcoming. There is no further threat to the community."

Police did not identify the man other than to say he was a 38-year-old male.





This is for informational purposes only and should NOT be construed as *"Instruction"*. As always, get professional training before practicing any Concealed Carry.

Sadly, home (and resident) break-ins have become increasingly common. However, there are a number of things you can do to either mitigate the threat and/or increase your safety factor.

If you are a homeowner, and it's reasonable, logistically plan your landscape. If possible:

Keep a clear area around your home so that anyone approaching your residence can easily be seen. Having motion sensing lights will also be more effective. Avoid bushes that someone can hide behind or keep them low cut.

An exception to close proximity shrubs might be to plant thorny, prickly bushes right under the first floor window. Some bushes to consider might be: Bougainvillea, Pyracantha, Blackberry, Roses, Barberry orYucca. An article on using Defensive Shrubbery can be found <u>here</u>.

Another deterrent is surrounding your house with motion sensor lighting. Most bad guys, like vampires, don't like light or being seen.

Battery operated security lights can be quite bright and be cost effective. In most cases they use "*D*" size batteries and only need to be replace annually.

Be sure to mount them high enough that they are not easily accessible without a ladder.

If you have a garage, always keep the garage door closed and locked. If there is an access door between the garage and your house, always keep that door locked as well.

## Home Protection

If you keep you car(s) outside, never leave anything of value inside. Most folks lock their car doors, some intentionally do not, trying to avoid broken car windows. Your call.

Most doors can be easily defeated. Quite often both the hinges and locks are secured by short screws that can, without much effort, be torn out.

For primary doors, replace those short crews on the locks and hinges with long, heavy duty 3" screws or bolts. Most all residential doors are framed with 2"x4" which are securely in place.

Designate a room in your home as a "*Safe Room*", most often this would be a bath room. Again, reenforce the locks and hinges with secure long screws or bolts.

If the door is an easily defeated hollow core, consider replacing it with a solid wood or even metal door. Add dead bolts at both shoulder level and knee level (also with long screws/bolts).

If your "*safe room*" is on an upper floor, also store rope ladder in the closet if you need to escape from the window.

If you have an old cell phone that is no longer connected to a provider, most cells still allow completing "911" calls, so keep that phone charged in your "*safe room*".

If you need to call 911, always stay on the line. Remember everything you say and every noise is recorded over the phone. With this in mind, if the perpetrator is at the door, yell a warning in your defense, such as: "*Go away! I have a gun and will shoot if I feel threatened! Police are on their way!*"

You can also ask that the police use a code word when they are finally at your door so you know it's the police, not the bad guy, at your door wanting to enter.

#### A Note on Light

Two primary units of measurement used for light are Kelvin (color) and Lumens (brightness).

**Kelvin** refers to the "*color*" of light. The lower the number the more red-yellow the hue. The higher the number the bluer the hue. An old fashioned warm yellowish tungsten light has a kelvin value of about 3,200 while daylight can range between 5,600 to 6,500 kelvin (and can appear bluish, especially at night)

**Lumens** (Im) refers to the brightness of light.(roughly speaking, one lumen is the equivalent to the light from one candle.) As comparative examples: 15 watt bulb = 40 Im; a 60 watt bulb = 800 Im; a 100 watt bulb = 1,600 Im.

## Shoot Your AR for One Tenth the Cost!

I recently found a very inexpensive way to shoot my AR-15 — by converting it to .22 LR Rimfire!



Instead of paying about 50¢ a round for .223/5.56 ammo, the cost drops to a tenth of that, only about 5¢ a round for a .22 rimfire!

I invested both in the .223/5.56 to .22 rimfire conversion kit, plus a recommended "*AR Reliability Kit*". Total investment (at the time of this writing) was just under \$200 (including shipping.)

The primary conversion unit, manufactured by CMMG, consists of a replacement Bolt Carrier Group (BCG) and includes three 25 round AR magazines. (additional mags, \$20-\$25 each,)

Installation of the conversion unit is extremely simple. Just slide out the original bolt carrier

group on the AR and slide in the conversion replacement .22LR BCG. — *That's it!* 

To be honest, it takes longer to load the 25 round magazine than it does to replace the BCG.

The accessory kit adds several features: There is a "*Pressure Plug*" for the recoil spring that helps press/secure the .22LR bolt into the chamber for a firm fit; an "*insert*" plug that fits in the charging handle to help avoid blowback (against the face) from the gas return; a small "*Bolt Buffer*" and replacement springs for both the extractor and firing pin.

I've taken it to the range and fired hundreds of rounds, using various brands of ammo, without a hiccup!

Considering the significant cost difference in ammo, the entire conversion unit will have paid for itself by about the 443 round!

Keep in mind, the .22 rimfire ammo tends to leave more residue, so frequent cleaning should be expected.

## **Easy Hints for Better Articles**

These simple hints can vastly improve your public commentary and article submissions!

1) Use your camera's flash on ALL outdoor photographs! The advantages can be dramatic! Your flash, even if it's just moderately powered (i.e. using a phone camera) can subdue or eliminate facial shadows!

You may have noticed, especially on a bright day, the deep shadows in a subjects face, If the subject is wearing a visor hat, the result is mostly a black blob (deep shadow) where the face used to be!

The other major benefit of *always* using your flash is it adds a sparkle (catchlight) to the subject's eyes. It turns the person from appearing cadaverous to looking lifelike, alert and attractive!

2) Another thing that can make world of difference is to **just get closer to the subject!** Do you really need to have your subject look diminutive? In most cases, empty sky, trees, shrubbery, buildings, walls, etc. add nothing to the story of the photograph. Small subjects also obfuscates detail and just plain wastes otherwise useable image space!

Another benefit of getting closer is it also makes your flash much more effective!

## Make it personal!

3) List the names of all who are prominently depicted in each photo! If a person is important enough to have their image displayed, they should also deserve the respect to have their names listed (with proper spelling!). You may know who they are, but chances are, 90% of the readers won'y know who the person pictured is!

4) Avoid using indiscriminate time frames, such as "today", "tomorrow", "yesterday", "last week", etc. Those references only apply to the moment you write them and are worthless for future reference.

FOR EXAMPLE: "*Today I broke my leg!*" However, that "*today*" occurred ten years ago! You're much better off using "*hard*" references, as 9/5/2022, or September fifth or whatever date that applies. Offering a "*hard*" reference keeps everything in perspective, whether your text is read the following week or even ten years from now!

It's the simple, little things, as these, that can make a BIG difference! Especially to everyone who views or reads your contributions!

- And make you look better in the process!

## WFO Article Submission: Image and Text "*Releases*"

Some of our readers expressed concern, when considering submission of an article for our newsletter, about Copyright laws pertaining to *"releases"* for names and images.

#### According to **Stanford Libraries: Copyright and Fair Use**, these guidelines would apply (Reprinted with permission):

### When to Use a Release

Whether you need to obtain a release depends on why you want to use a person's name or image. If your use is for commercial purposes—for example, using a person's photo in an advertisement—you need to obtain a release. If your use is for



## How To Take Better Pictures

Whether you are using a smart phone or a more conventional camera, these tips are for everyone!

1) When composing an image, use the "*thirds*"

theory, where the most important part of the image is in one of the "*third*" frame sections, but NOT in the middle.

Avoid Important Subject Matter In This Area	

2) Check your

background. Try and avoid

poles or branches growing out of the subject's head, or an unwanted distraction in the back;

3) Always use your flash, even in bright sunlight. It can help fill in some closer shadows and also adds a *"sparkle"* to a person's eyes;

4) Take plenty photos of the same subject. With digital, the cost is negligible and it helps avoid an unwanted blink or glitch;

5) If you have the option, always use the highest quality image (largest size) setting;

6) If you're submitting the image for publication, DO NOT edit it. We'll do that;

7) If you're using images to tell a story, use at least three sets of images:

1). A "long" shot to set the overall scene;

2). A "middle" shot for a descriptive view;

3). A "Close-up" for detail;

informational purposes such as a documentary film or news article, you may not need a release.

#### Informational Uses

You do not need a release to use a person's name or image for informational purposes. An informational (or "editorial") purpose is anything that informs, educates, or expresses opinions protected under the First Amendment of the United States Constitution freedom of speech and of the press. An informational use would include using a person's name or photograph in a newspaper or magazine article, educational program, film, nonfiction book, or informational website.


