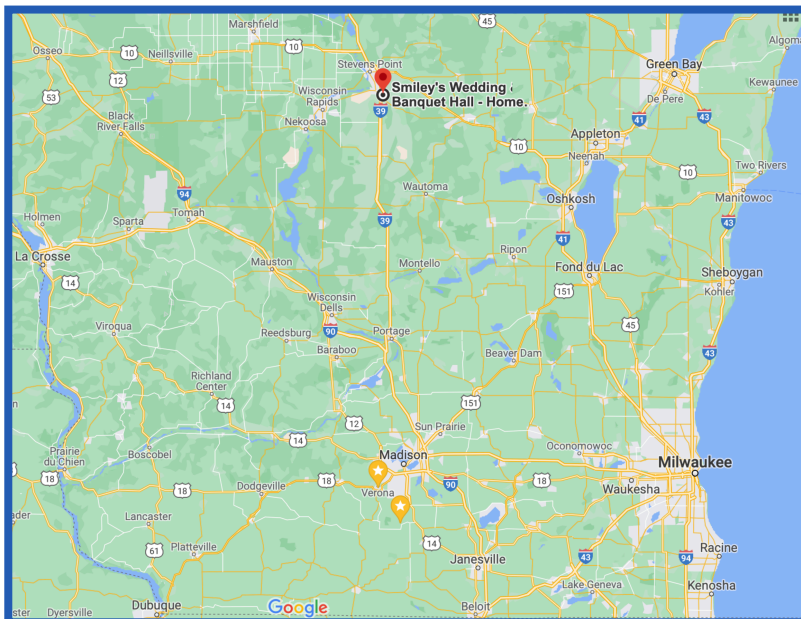

## Democrats Propose Bill to Restrict Youth Competition

A number of Kenosha area Democrats have circulated LRB 5334/1 in the legislature in Madison that would limit possession of a firearm by someone under 18 years of age.

This would include restrictions on target practice, hunting, firearm training or military service.

They are doing this in response to the Rittenhouse case to make sure that "next time" it would be illegal for someone like Rittenhouse to possess an AR15 for self defense. They are caving to political pressure by anti-gunners to change the law.

Our reading of their bill would make it impossible for a person under age 18 to possess a firearm for competition or any other purpose other than the listed exceptions — and there doesn't seem to be an exception for transporting the firearm to or from hunting or target practice, or even storing a firearm.

This would negatively impact competitive junior shooting sports and youth gun ownership and is unconstitutional.

Of course Wisconsin Firearm Owners will register and work against this legislation. If you would like information on how to make your voice heard on this, send us a message!

- ★ **Most important:** Include your name, contact information (phone, email) and topic source.

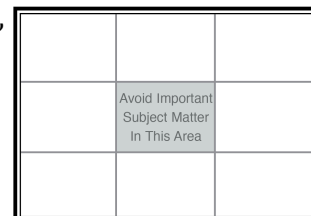

## How To Take Better Pictures

*Whether you are using a smart phone or a more conventional camera, these tips are for everyone!*

1) When composing an image, use the "*thirds*" theory, where the most important part of the image is in one of the "*third*" frame sections, but NOT in the middle.



2) Check your background. Try and avoid poles or branches growing out of the subject's head, or an unwanted distraction in the back;

3) Always use your flash, even in bright sunlight. It can help fill in some near shadows and also adds a "*sparkle*" to a person's eyes;

4) Take plenty photos of the same subject. With digital, the cost is negligible and it helps avoid an unwanted blink or glitch;

5) If you have the option, always use the highest quality image (largest size) setting;

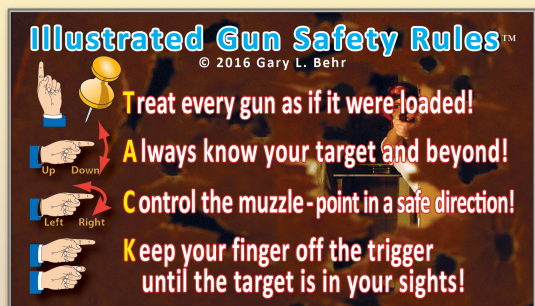
6) If you're submitting the image for publication, DON'T edit it. We'll do that;

7) If you're using images to tell a story, use at least three sets of images:

- 1). A "*long*" shot to set the overall scene;
- 2). A "*middle*" shot for a descriptive view;
- 3). A "*Close-up*" for detail;

## Wisconsin Firearm Owners Testify in Madison for Assembly Bill AB495

Wisconsin Firearm Owners testified in Madison on January 5<sup>th</sup>, for AB495 which would make it legal for people with concealed carry to have their Firearm in their car when dropping off or picking up their kids at school.

Current law allows authorized Concealed Carry holders to have their firearm with them if they are on the street, BUT not while on school property, preventing CCW holders from driving-up a school driveway, parking lot or other school access point to pick up their kids.

This would allow a Wisconsin CCW holder or out of State licensee to do so without committing a Class 1 felony.

*For anyone who does NOT possess a valid WI CCW permit:*

[Section 4, 948.605 (2) (a) 2.] Any individual who knowingly possesses a firearm at a place that the individual knows, or has reasonable cause to believe, is within 1,000 feet of the grounds of a school is subject to a Class B forfeiture (not to exceed \$1,000).

### Analysis by the Legislative Reference Bureau

Under current law, a person is generally prohibited from possessing a firearm on the grounds of a school. A person who violates the prohibition is guilty of a Class I felony. Under this bill, a person who has a license to carry a concealed weapon may possess a firearm in a vehicle on the grounds of a school.



## Shorter Wait-Times for Suppressor Applicants

### ATF Launches New Electronic Form 4

For anyone who has tried to purchase a National Firearms Act (NFA) item, such as a [suppressor](#) or a short-barreled rifle

(SBR), the dark void that your tax application disappears into for up to a year at a time is not a laughing matter. An upgrade to the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) filing system, allowing Form 4s to be submitted electronically, could see that filing process simplified and approval times get shorter.

To get the details on the new eForm 4s, we spoke with Brandon Maddox, owner and CEO of [Silencer Central](#). Maddox explains, "Basically it's taking the current paper

*process and converting it to all digital, ... the whole government system has moved to a cloud-based system. ... because it can process quicker online when it's submitted."*

For those who have never purchased a NFA item, the process goes like this. You pick out a [suppressor](#) or SBR and pay the full purchase price or put down a deposit. You fill out and submit an ATF Form 4 "Application for Tax Paid Transfer and Registration of Firearms," submit photographs and fingerprints, pay your \$200 tax and wait.

According to the ATF, the average processing times for Form 4s at the end of September 2021 was eight months. Maddox says his customers have experienced a nine to 12 month wait. By allowing applications to be submitted electronically, those wait times will be significantly shortened.

The process to electronically file a Form 4 will be very similar to the current paper process. An applicant will have to create an online account with the ATF and have their identity verified. They will fill out an electronic version of the current form and upload a digital passport-type photo of themselves. Fingerprints will have to be submitted by mail, if the dealer you are purchasing from does not have a

digital fingerprint system. The customer will be notified of problems or mistakes, and will receive the result of their application, by email.

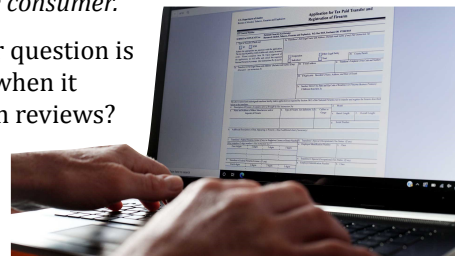
*"The biggest difference is that the customer will be 'kept in the loop,'" Maddox explains. "They'll get emails and updates of when it was submitted, when the tax stamp is paid and when it's approved. So it creates an additional level of transparency for the consumer."*

So the million dollar question is how fast is "faster" when it comes to application reviews?

"The ATF has told us that they are going to staff to a 90-day

turnaround," Maddox explains. *"So they're saying once the approval time gets beyond 90 days, they'll hire more staff to keep it at 90 days."*

According to the ATF, forms that can be currently electronically filed are approved in about a third of the time as their paper counterparts.



## *Top gun magazine editor makes* **5 Predictions for 2022**

Kevin Michalowski, Executive Editor of the award-winning Concealed Carry Magazine, recently revealed his top 5 gun predictions for 2022.

And they are a great reminder that you need to make sure you're prepared (especially #3).

**#1: Supreme Court Will Rule in FAVOR of American Gun Owners.** There is a HUGE 2nd-amendment case in front of the Supreme Court right now. It revolves around New York's extremely *restrictive* gun laws.

A ruling is supposed to come down around the beginning of summer. Kevin thinks it will be in FAVOR of more 2nd amendment freedom.

**#2: Everyone Will Be Obsessed with Red Dot Sights on Pistols.** Red dot sights for handguns have been gaining more traction in recent years.

And with big improvements in technology and consumer awareness, red dots will become very much a part of the mainstream in 2022.

**#3: Another Ammo Shortage Will Happen In 2022.** As prices come back down and supply increases in the New Year, people who have been waiting to buy will take their opportunity.

There will be a mad rush on ammo shelves which will jack up prices and reduce supply AGAIN.

This is almost guaranteed to happen if there is a repeat of the rioting that happened in major cities during the summer of 2020.

**#4: Politicians, Actors, and Prosecutors Will Continue to Be CLUELESS About Guns.** Kevin says we will see some major gaffes about guns and self-defense on the internet by gun-control advocates.

Even after the Alec Baldwin incident, gun-control advocates will still not get the training they need to speak intelligently about the issue.

**#5: People Will KEEP Using Guns to Defend Themselves.** With millions of new gun owners in America, we are going to see more people getting trained, taking their family's safety seriously, and most importantly, SAVING LIVES. *And America will be better off for it.*

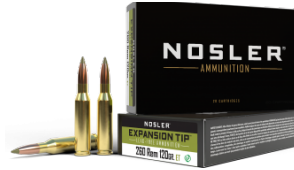

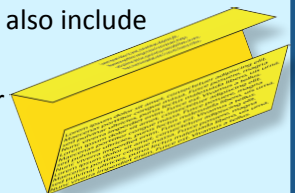

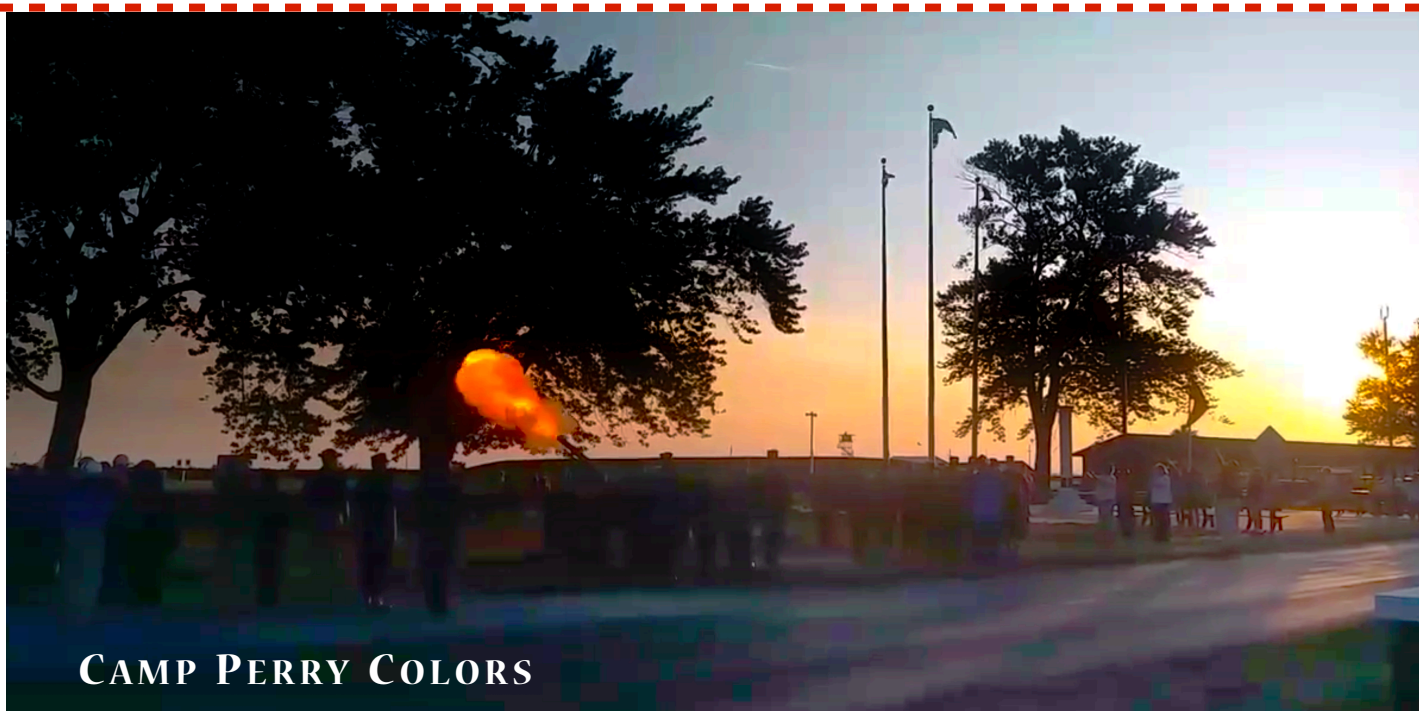
