



ELIGIBILITY: Open to all shooters. To be the Wisconsin State Champion, or recipient of any

State Champion class award, you must be a Wisconsin resident and a member of

WI-FORCE. There will be no exceptions.

ENTRIES: Entries will be limited to 40 competitors, 20 per day, unless there is a major change

in the status of the current COVID-19 Pandemic, and ammo/component shortages.

Entries will be CONFIRMED, ONLY, upon receipt of entry fees and the completed

registration from. Please complete all blanks.

MATCH ENTRY FEES: Registration fee is \$13.00 (\$5.50 to NRA, \$4.00 to Wisconsin FORCE

Pistol Association and \$ 3.50 BRC) Individual matches are \$3.00 each.

One gun fee = \$30.00, Two gun fee = \$40.00 - Based on available space.

Across-the-board shooters take precedence.

ACROSS-THE-BOARD ENTRY (including registration) is \$50.00, if paid with entry registration form - \*\* \$55.00 ON THE DAY OF THE MATCH \*\*

Entry Fee will be returned if cancellation received 1 week before match date.

Less than 1 week, \$10.00 deducted. If no cancellation, there will be no refund.

RELAYS: Relay #1 - Saturday 9AM. Relay #2 - Sunday 9AM. There will be approximately

1/4 hour break between 22 & CF and approximately 1 hour lunch break between

CF and 45.

RULES: Current NRA pistol rules will apply.

SCORING: Competitors will score and change targets. Scoring plugs will be restricted to

range personal only. A fee of \$2.00 will be charged for each challenged target.

Fee will be returned if challenge is sustained.

CLASSIFICATION: NRA classification system will be used. Any class with less than five

entries will compete in the next higher class. If there are less than five entries in the master class, they will compete for match winner only.

EXCELLENCE IN COMPETITION MATCH(SERVICE PISTOL), REVOLVER DISTINGUISHED & 22 DISTINGUI

NOTE: The EIC Match will be governed by the current edition of CMP/NRA Rules.

Rule 2.5 EIC permits Pistol EIC Matches to be conducted on both days

of the State Championship. EIC Matchs will be fired each day at the conclusion

of the 2700. The Distinguished Revolver Match will be fired at the

conclusion of the EIC Pistol Match. All guns will be weighed and the your

ammunition checked during the noon break and be subject to spot checks on the line. There will be extra fees for these matches. We will also have a Distinguished 22 Match. This will be fired along

with the other Distinguished Matches.

CMP Service Gun Match - \$25.00, CMP 22 - \$25.00, and NRA Revolver - \$10.00.


