New York AG seeks to dissolve NRA in new lawsuit

Letitia James accused the NRA of having 'a culture of selfdealing,' taking millions of dollars for personal use

NRA in the crosshairs as New York Attorney General files lawsuit to dissolve organization

Attorney General Letitia James announced that her office has filed a lawsuit against the National Rifle Association (NRA). James is seeking to have the organization shutter its doors, bringing a close to its nearly 150-year old existence.

New York Attorney General Letitia James announced Thursday that her office has filed a lawsuit against the National Rifle Association and its leadership, including Executive Vice President Wayne LaPierre, looking to dissolve the organization.

James accused the organization of having "a culture of self-dealing," taking millions of dollars for personal use and granting contracts that benefited leaders' family and associates.

"For nearly three decades, Wayne LaPierre has served as the chief executive officer of the NRA and has exploited the organization for his financial benefit, and the benefit of a close circle of NRA staff, board members, and vendors," the 163-page complaint states.

The Washington, D.C. Attorney General's office also sued the NRA on Thursday based on similar allegations.

"Charitable organizations function as public trusts — and District law requires them to use their funds to benefit the public, not to support political campaigns, lobbying, or private interests," Attorney General Karl Racine said.

The New York lawsuit alleges that LaPierre, former chief of staff Joshua Powell, former CFO Wilson "Woody" Phillips, and general counsel John Frazer, engaged in self-dealing and ignored conflicts of interest in violation of NRA policy. Alleged conflicts included granting millions of dollars worth of contracts to companies like information technology firm HomeTelos, whose CEO had a personal relationship with Phillips that was not disclosed at the time.

This was later reported by staff members of Phillips, who acted as whistleblowers in 2018, the complaint says.

The lawsuit also details personal expenses for which LaPierre was allegedly reimbursed by the NRA. These included private air travel for him and his family and gifts to friends, on top of millions of dollars for personal and home security. The lawsuit also claims that LaPierre hired Phillips, Powell, and Frazer "despite their lack of skills or experience for their respective roles and responsibilities."

Any attempts to push back against LaPierre, the complaint alleges, "were quashed and ignored." For example, the complaint alleges that after the NRA President learned about whistleblower complaints and began looking into NRA governance, LaPierre "retaliated" against him by withdrawing his support for renomination. The president eventually resigned.

Additionally, the complaint alleges that the NRA filed false reportings with the New York Attorney General's office and the IRS, specifically regarding compensation to LaPierre, Phillips, Powell, and Frazer.

In addition to asking for the organization to be dissolved, James' office seeks to have LaPierre and Frazer removed from their positions, and a declaration from the court saying "that directors or members in control of the NRA have looted or wasted the NRA's charitable assets, have perpetuated the corporation solely for their personal benefit, or have otherwise acted in an illegal, oppressive or fraudulent manner[.]"

"The NRA's influence has been so powerful that the organization went unchecked for decades while top executives funneled millions into their own pockets," James said in a statement. "The NRA is fraught with fraud and abuse, which is why, today, we seek to dissolve the NRA, because no organization is above the law."

NRA President Carolyn Meadows called the lawsuit "a baseless, premeditated attack," claiming it targeted not just the NRA, but the constitutional rights it defends.

"You could have set your watch by it: the investigation was going to reach its crescendo as we move into the 2020 election cycle," Meadows said in a statement. "It's a transparent attempt to score political points and attack the leading voice in opposition to the leftist agenda. This has been a power grab by a political opportunist – a desperate move that is part of a rank political vendetta. Our members won't be intimidated or bullied in their defense of political and constitutional freedom."

Meadows added that the NRA "will not shrink from this fight – we will confront it and prevail."

To that end, the NRA <u>countersued</u> James, seeking a court declaration that they are following state notfor-profit law and alleging that The New York Attorney General is targeting the organization for its political positions, violating its free speech rights.

"The New York Democratic Party seeks to harass, defund and dismantle the NRA because of what it believes and what it says," the lawsuit says. "Only this Court can stop it."

Bloomberg's Gun Control Group Pours \$15 Million Into Races in 8 States

By Reid J. Epstein July 23, 2020Updated 9:36 a.m. ET Michael R. Bloomberg's gun control organization will focus its political advertising spending this fall on eight states where it aims to help Democrats flip three Senate

seats, wrest control of state legislatures and lift former Vice President <u>Joseph R. Biden Jr.</u> to victory in Florida. The group, Everytown for Gun Safety, is making an initial \$15 million investment in digital advertising in the states, an opening outlay of the \$60 million it has pledged to spend during the 2020 campaign.

It includes \$5 million earmarked for Florida, the lone state where Everytown plans on advertising in the presidential contest; \$3.5 million in Texas, where the group is targeting six House races; and \$1 million to \$1.5 million in Arizona, lowa and North Carolina — three states where it will advertise in Senate races — as well as in Minnesota and Pennsylvania.

The group also plans an initial \$500,000 investment in Georgia, where, in addition to the state legislative contests, the group will advertise on behalf of Representative Lucy McBath, a suburban Atlanta Democrat who used to work as an Everytown spokeswoman.

Though the coronavirus pandemic and protests over racial disparities in policing have dominated Americans' attention this summer, John Feinblatt, Everytown's president, said he believed gun violence was more important to voters now than it had ever been.

"Post-Covid, our polling tells us it's more critical to voters than ever," Mr. Feinblatt said in an interview on Wednesday. "It's become a litmus test for voters, as it was in Virginia."

Everytown aims to replicate its success from Virginia's 2017 and 2019 elections, when it backed Democrats who <u>overturned a generation of Republican control of the state legislature</u> with investments that pale in comparison to what major statewide races cost.

The group is now aiming to install Democratic allies atop state governments, through which it then hopes to enact sweeping gun control measures, as Virginia did this year.

Everytown remains largely backed by Mr. Bloomberg, the billionaire former mayor of New York, but it has an increasing number of outside contributors, <u>including Connie Ballmer</u>, the wife of the former <u>Microsoft chief executive Steve Ballmer</u>. Ms. Ballmer gave \$7 million in April.

The organization's focus on digital advertising comes during what its top political aides said was the fastest change in media consumption habits since the dawn of the digital age. With millions of Americans homebound because of the pandemic, nearly half of all television consumption is now on streaming platforms.

"2020 looks more like 2025," said Charlie Kelly, a senior Everytown political adviser.

Mr. Kelly estimated that the cost to reach voters on digital platforms across enough competitive state legislative districts to flip a state chamber was a fraction of the resources required in a federal or statewide race. Mr. Kelly said Everytown would spend to help Mr. Biden in Florida, but not elsewhere, after consultation with other Democratic super PACs, like Priorities USA, that would take responsibility for different states.

"The goal is to win and everybody comes to the table to do that," Mr. Kelly said. "Post-2016, people were like, 'We got to get ourselves together on that front."

Everytown is just one element of Mr. Bloomberg's political largess. He spent nearly \$1 billion on his own presidential campaign, which ended after he won the Guam caucuses but no states. Mr. Bloomberg had pledged to pay his staff members through November, but later abandoned those plans and donated the \$18 million remaining in his campaign account to the Democratic National Committee.

Field staff members for his campaign <u>subsequently filed class-action lawsuits</u> arguing they had been tricked into accepting jobs.

Mr. Bloomberg's personal super PAC, Independence USA, spent about \$60 million on 2018 races but has yet to engage in 2020 contests.

Everytown's success has come as the National Rifle Association's financial muscle has atrophied. The 2018 midterm elections were the first time gun control organizations — Mr. Bloomberg's Everytown and a group founded by former Representative Gabrielle Giffords of Arizona — had outspent the N.R.A. in federal elections.

"No question about it, the N.R.A. has never been weaker," Mr. Feinblatt said. "It's fair to say they are going to be spending more money on legal fees than they are digital or TV ads this cycle."

Everytown's \$60 million commitment for 2020 is twice what it spent on the 2018 midterms.

The N.R.A., <u>which spent \$54 million on the 2016 elections</u> but just \$20 million in 2018, has yet to make a public commitment for the 2020 elections.

Amy Hunter, an N.R.A. spokeswoman, declined to reveal what the gun-rights organization would spend this year but predicted voters would reject gun control proposals put forth by Mr. Bloomberg, Mr. Biden and former Representative Beto O'Rourke of Texas, who as a presidential candidate last year called for the government to seize assault rifles from people who own them.

"2020 has been a bad year for the Bloomberg team," Ms. Hunter said. "First, after spending billions, Mike crashed and burned early out of the presidential primaries and, then, millions of voters join the ranks as gun owners. N.R.A. members and gun owners know what is at stake and they will vote for freedom — not for the Biden-Beto gun confiscation scheme."

Remington Arms declares bankruptcy despite surging gun demand

Civil unrest, worries about personal safety have driven firearm sales to record highs

<u>Firearms</u> maker Remington Arms Co. filed for <u>bankruptcy</u> protection for the second time since 2018, weighed down by more debt than it can repay even as fearful Americans <u>buy</u> more guns than ever.

Remington, which supplies weapons for hunting, shooting sports, law enforcement and the military, sought chapter 11 protection and will try to sell its business at a time when civil unrest and worries about personal safety have driven firearm sales to record highs.

The chapter 11 petition in the U.S. Bankruptcy Court in Decatur, Ala., marks Remington's second restructuring since 2018, when it filed for chapter 11 and transferred ownership to investors including Franklin Resources Inc. and JPMorgan Chase & Co.

Remington has been searching for potential buyers and was in talks to sell itself out of bankruptcy to the Navajo Nation before negotiations collapsed in recent weeks, leaving the company without a lead bidder, or stalking horse, in place.

The manufacturer's firearms and ammunition businesses could be sold off separately, according to a person familiar with the matter.

GUN SALES SOAR 145% IN JUNE AMID PROTESTS, CORONAVIRUS PANDEMIC

Despite shedding roughly \$775 million in debt in 2018, the company has struggled with high interest costs and has faced litigation related to the 2012 Sandy Hook Elementary School massacre, in which the killer used a Bushmaster rifle manufactured by Remington.

Meanwhile, gun-control activists have put pressure on investors and retailers to reconsider their ties to the firearms industry, particularly following the 2018 school shooting in Parkland, Fla.

The industry's fortunes tend to rise and fall based on the country's political climate. Under former President Obama, firearm sales grew as enthusiasts worried about potential regulations. Sales softened after President Trump took office pledging to defend gun rights.

Demand has skyrocketed again since March as measured by Federal Bureau of Investigation background checks, a proxy for sales. Background checks in June for civilians seeking licenses to carry guns were the highest since the FBI began conducting them 20 years ago.

Gun stores, which have largely stayed open during the Covid-19 pandemic, are selling to many first-time buyers worried about personal safety over the civil unrest that followed the killing of George Floyd in police custody and the ensuing movement to reduce police funding.

While many types of retail inventory have plummeted in value during the pandemic -- such as apparel, fashion accessories and footwear -- firearms are holding up relatively well, according to appraisal and liquidation experts.

But buoyant sales at the counter don't immediately flow to manufacturers like Remington, which traces its roots to 1816 and makes firearms at facilities in Ilion, N.Y., and Huntsville, Ala. Some firearms companies also face supply-chain issues that have been exacerbated by the pandemic, making it difficult to ramp up production to meet growing demand.
